Writ petition (civil) praying inter alia that in the circumstances stated in the affidavit filed along with the WP(C) the High Court be pleased to stay the operation of Exhibits-P7 and P8 with a further direction to consider the application for grant of permission by the 1st respondent without reference to Exhibit-P7 and further direct the 2nd respondent to issue the continuation of affiliation without insisting for the compliance of the stipulations as contained in Exhbit-P8, pending

disposal of the Writ Petition.

This petition coming on for admission upon perusing the petition and the affidavit filed in support of WP(C) and upon hearing the arguments of SRI.GEORGE POONTHOTTAM (SENIOR) along with M/S.NISHA GEORGE & SIDHARTH.R.WARIYAR, Advocates for the petitioners, SRI.MANU S, ASSISTANT SOLICITOR GENERAL OF INDIA for R1, SRI.P.SREEKUMAR, Advocate for R3 and of GOVERNMENT PLEADER for R4, the court passed the following:

ORDER

It is the specific case of the petitioners in these matters that the National Commission for Indian System of Medicine (NCISM) do not have the competence to frame Regulations with respect to the determination of salary to the faculty of the self-financing colleges; and they refer to Section 55(o) of the National Commission for Indian System of Medicine Act, 2020 (hereinafter referred to as 'the Act' for short).

Sri.Kurian George Kannamthanam and Sri.George Poonthottam – learned Senior Counsel appearing in these matters, vehemently argued that, going by Section 55(o) of the Act, the NCISM cannot fix salary of the faculty of the self-financing colleges and that their competence are confined to the conduct of National Teachers' Eligibility Test for Indian System

of Medicine and nothing more.

The learned Assistant Solicitor General of India – Sri.S.Manu, however, sought time saying that his client has to respond to the afore allegations, through a counter pleading.

That said, since the petitioners have shown me the schedule fixed by the Kerala University of Health Sciences (KUHS) for completing the admission process and commencement of classes, I am of the view that they are entitled to an interim order, lest the courses are prejudiced in future.

Resultantly, I adjourn these matters to be called on 29.09.2022; within which time, the NCISM, as also the other respondents, will complete their counter pleadings.

Until the next posting date, I direct the NCISM to process the applications of the petitioners and forward them to the KUHS as per the statutory scheme, without insisting payment of salary to the faculty of the self-financing colleges under their Regulations; however, on condition that if these Writ Petitions

are to finally end against the petitioners, they will pay the said amount to the faculty, along with all applicable interest and charges, as may be statutorily required.
