Dear Madam /Sir,

With regard to above mentioned subject, this is to bring your notice that, as per the National Commission For Indian System of Medicine (NCISM) Act 2020, subsection (2) of section 55 and the Minimum Standard of Ayurveda Education Regulations -2022 published dated 16-02-2022 vide the Gazette of India No. 93 (Regd. No. D.L. 33004/99), and the table 18 specifying the minimum monthly salary to the teachers working in Ayurvedic institutions, NCISM, had directed the Ayurvedic institutions to pay the **minimum monthly salary** as under :

As the NCISM is an apex governing, legally constituted body by enacting a law in the Parliament, it's all regulations including duration of study, subjects, pay etc are binding for all the Ayurvedic colleges operating in India. Kerala university health Sciences in its letter no. 9443/2022/A1/Acd-AYUSH/KUHS dated 01-08-2022 (copy attached) had already issued the direction to the colleges under its jurisdiction for paying the teachers as per the new pay matrix issued by the NCISM. In this context, we request you to issue the letter to the managements of all the Ayurvedic colleges operating in the state to pay the monthly salary to the Ayurvedic teachers in accordance with the regulations of NCISM, and kindly also ensure that the management governing these colleges pay it honestly through bank transfer in salary account as recommended by NCISM. We have already communicated to you in this regard earlier in the month 28-02-2022 and 09-03-2022. Still there is no response from your end.

As these directions are applicable from this year vide letter F.No. BOA/Regulations/UG/7-10/2021, the pay structure should be implemented from this year only.

Sub : KUHS- Academic-AYUSH- Minimum basic pay for the Self-financing colleges as prescribed in the New Regulation issued by National Commission for Indian System of Medicine -reg

Ref :- National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education)-Regulation 2022 published in the Gazette on 16.02.2022.

As per the National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education)-Regulation - 2022 published in the Gazette vide notification dated 16.02.2022 clause 17 (d) (b) mandated the minimum basic pay for the faculties of self financing colleges including Central Private deemed University or State Private University as per the Table 18 of the Regulation.

In the above circumstance, the Principals of the all affiliated Self Financing Ayurveda Colleges are directed to follow the pay structure as mandated in the table 18 of the NCISM Regulation. The same shall be cross checked at the time of conducting inspection with regard to grant of Continuation of Provisional Affiliation.
