Dear Sir,

As despite your above said letters to the private Ayurvedic colleges, they are neither paying regular salary nor revised salary to the staff. Hence giving some suggestions to you for effective implementation of this policy

A] Ask the management to constitute the local management council of the college in which Principal remains the chairman and other college teachers and social activist stay as members. Such type of councils are already been made compulsory by Maharashtra University of Health Sciences, Nashik in colleges affiliated to it. But unfortunately these councils are not functional.

B] Make it compulsory for the Principal of private Ayurvedic college, to open an account in the name of the college which will be operated jointly by the Principal and the college council members.

C] Appraise the Fees regulating Authority of respective states about revised pay structure suggested by the NCISM as per MSE dated 16/02/2022.

C] Make it compulsory for colleges to deposit the tuition fees collected from the students in above account. From this account, salary can be made regularly.

Only by this way the regular salary of the staff could be ensured.
