Subject – Suggestions regarding opinion on Minimum Essential Standard [MSE] Regulation 2023

Reference –1] Your letter Ref. No. BOA/2-C/2022 dated 25-02-2023

Dear Sir,

With regard to above said subject, I am on behalf of my organization suggesting you as follows :

1] Establishment of New Ayurveda Undergraduate Institution point No. 4 (1) wherein OPDs of Shalya, Shalakyas, Kayachikitsa, Balroga, Streeroga, Panchakarma and Visha Chikitsa have been made essential. Whereas these OPDs are essential mandate then where these OPD recommended Pathology laboratory and Radiological investigations will be done remains unanswered. Hence, we demand the appointment of higher and lower faculties of Roganidana and Vikrutivigyana along with full functional pathology and Radiology laboratory under Roganidana while opening the New Ayurveda Undergraduate Institution, should be made essential.

2] Point no. 28 (xv) Specialty OPD – Under this heading, instead of any member interested of departments mentioned, Nidan being the far most and first essential step of diagnosis, it may be granted the separate clinical OPD with Day wise inter se change of faculties along with laboratory services.
