Respected Sir,

This is to bring your notice that our member **Dr. Shrikant Tambe** appeared for the interview for above said post as per the interview letter issued by you on 16th November 2022 at UPPSC, Prayagraj (U.P.) office. It is learnt that advertisement for said post was published in the year 2013 (Adv. No. 1/2013-14 Div. NO. S-11/53, dated 24-08-2013 (AYUSH Shiksha). However, the interview was conducted far late after 9 years on 16th November 2022. It is also brought into the notice that total 4 posts (Professor - Roganidana) were advertised. Out of which 1 post was reserved for SC category, 1 for OBC category and 2 for Open category. There were 05 (Five) candidates were present for the interview. Out of which 02 (two) candidates are from Roga Nidan Subject and 03 (Three) from Kayachikitsa subject.

UP Public service commission has to follow the rules of CCIM/NCISM while recruiting the staff at Ayurvedic colleges under it's jurisdiction.

As per the rules of CCIM amendment dated 25th April 2012 clause no. 12 it is clearly mentioned that "In absence of the candidate of Post-graduate qualification in the concerned subject the candidates of the allied subject shall be eligible." [Annexure no. 2]

Also As per the NCISM notification dated 16th February 2022 clause no. 17 Qualification and experience for teaching staff—"A Post graduate qualification in Ayurved in the concerned subject is essential." The allied system is totally closed, no candidate in allied subjects should be appointed. The notification is attached herewith. [Annexure no. 3]

The result of above said Interview was declared on 19th November 2022, but it is observed that candidates from Kayachikitsa subject were selected for the subject of Roganidana even when two eligible candidates from proper from Roga Nidan subject were available for the interview. It is not only clear violation of rules set in this regard but highly objectionable and give the space for doubting the role of unfair means in selection process.

I request your intelligent self to look into the matter urgently and take corrective steps promptly failing which we will not only approach the court but will also demand the CBI inquiry in this matter.
